



GUIDE FOR AUTHORS

Llull is published on a yearly basis (i.e., one volume in one or two issues per year). The Journal accepts for publication original papers that must previously undergo an external double-blind peer review, and which must deal with any aspect concerning the production, circulation, teaching and/or implementation of scientific and technical knowledge.

Subjects may cover one or more of the following areas: new historical data originating from primary sources; critical analysis of known data; critical review of previous historical research; historical studies on recent scientific research; hitherto unpublished original sources; translations and/or reprints of hitherto inaccessible data; critical annotated bibliography; and critical chronology. Any generalization must be substantiated by discourse and documentation. The Journal excludes no languages. Authors must send their articles with two abstracts, one of them necessarily in English and about 200 words long. They should also propose a title in English for their article, as well as some keywords (at least three) in both Spanish and English in order to facilitate the inclusion of their work in the bibliographical compendiums. Some examples may be found in 25 Años de LLULL, Revista de la Sociedad Española de Historia de las Ciencias y de las Técnicas: Índice de los volúmenes 1-25 (1977-2002), a copy of which may be obtained from the Editorial Office. Finally, authors should submit a brief biographical sketch (about 10 lines) for the notes on Contributors section of the Journal. Current affiliation, full postal address, and e-mail address must be included.

Originals must be sent electronically (redaccion.llull@gmail.com) as PDF files, with no properties or metadata. After their acceptance, they should also be sent as Ms-WORD files. They should be no longer than 13.000 words (ca. 30 DINA4 pages), including notes, bibliography and tables. If the original is longer, its author should consider publication in separate parts. Bibliography should be organised alphabetically by author. We recommend that for sources that are difficult to access, the libraries or news archives where they can be found are specified, as well as the kind of original that has been used.

References to a **journal papers** (including punctuation):

- 1. Surname(s) and name of the author(s) in small caps
- 2. Year of publication (in brackets)
- 3. Full title of the article (between quotation marks).
- 4. Full or international abbreviated name of the journal (italics),
- 5. Volume number (italics) followed (no space) by the issue number (italics, in brackets), initial and last pages separated by a hyphen.

Example: AUSEJO, Elena; VELAMAZÁN, María Angeles (1989). "Los planes de estudio en la Academia de Ingenieros del Ejército de España en el siglo XIX". *Llull*, *12(23)*, 415-454.

If the journal article has a DOI (Digital Object Identification), this information will be included between the < and > signs at the end of the reference.

Example: MILLONES-FIGUEROA, Luis (2003). "La historia natural del padre Bernabé Cobos. Algunas claves para su lectura". *Colonial Latin American Review, 12(1),* 85-97. <doi: 10.1080/10609160302337>.

References to a **book** (including punctuation):

- 1. Surname(s) and name of the author(s) in small caps; for an editor, add (ed.)
- 2. Year of publication (of the edition used, in brackets)
- 3. Full title (italics).
- 4. Collection (between quotation marks), issue.
- 5. Edition number, place of print, editor, number of volumes.
- 6. Any other additional data (such as foreword, data from previous editions or translations).

Example: BERNAL, John Desmond (1979). *Historia social de la ciencia*. Serie "Historia/ Ciencia/Sociedad", 9. 5ª edición, Barcelona, Península, 2 vols. Traducción, de Juan Ramón Capella, de la 3ª edición en inglés, 1964.

References to a **chapter** in an edited book or in proceedings (including punctuation):

- 1. Surname(s) and name of the author(s) of the chapter, in small caps
- 2. Year of publication (of the edition used, in brackets)
- 3. Full title (between quotation marks).
- 4. Preposition "En", as appropriate:
- 5. Name(s) and surname(s) of the director(s) or editor(s) of the book (ed.)
- 6. Full title of the book (italics) and number of the volume, as appropriate.
- 7. Collection, as appropriate (between quotation marks), number.
- 8. Edition number, place of print, editor, initial and last page of the chapter, separated by a hyphen.
- 9. Any additional data, if needed.

Example: CALATAYUD, María Ángeles (1993). "La Comisión Científica del Pacífico y la fotografía en la expedición de 1862-1866". En: Barbara Thomas, Fernando Palacios, María del Carmen Martínez López (ed.) *Libro del Congreso*. *Simposio Internacional sobre Preservación y Conservación de Colecciones de Historia Natural*, 2. Madrid, Dirección General de Bellas Artes y Archivos, 411-422.

References to **newspaper articles** (incluiding the official newspapers) will be made:

- 1. Surname (in small caps) an name(s) of the authors(s) of the chapter
- 2. Year od publication (of the edition used, in brackets).
- 3. Full title (in quotation marks).
- 4. Full name or international abbreviation of the newspaper (italics).
- 5. Day/month/year (in arabic characters), and the indication of the pages.

Example: PEÑALVER, Patricio (1880). "Los cables submarinos". *Revista de Telégrafos,* 01/03/1880, 37-39.

References to **web pages** or electronic resources will be made:

- 1. Surname an name of the author or authors (in small caps): in the case of being a editor, it will bw added '(ed)', as long as it is epecified in the reference text.
- 2. Year of generation of the resource, in parentheses. If not stated, the year of consultation will be indicated.
- 3. Completed title (italics).
- 4. Editorial or institutional mention of responsibility.
- 5. Complete address of the resource, between the signs < >.
- 5. Date of consultation between brackets [day/month/year (in arabic characters)].

Example: GARCÍA GARRALÓN, Marta (2021). *Emblemata Farmacéutica. Nombres y signos farmacéuticos en las antiguas boticas europeas.* Archivo del Colegio Oficial de Farmacéuticos de

Madrid. https://www.cofm.es/recursos/doc/portal/2019/05/08/emblemata-farmaceutica-nombres-y-signos-farmaceuticos-en-las-antiguas-boticas-eu.pdf. [Consulta: 30/03/2023].

Indicate references in the text or in footnotes by surnames, year of publication (and numbers of volumes and pages, as required) in square brackets.

For instance: in Bernal [1979, vol. 1, p. 37] we may observe that... (If it appears in the text) 1. See BERNAL [1979, vol. 1, p. 37] (if it appears in the footnotes).

Footnotes that only give bibliographic information should be between square brackets in the text itself [Bernal, 1979, I, p. 37] and referenced in the bibliography.

Authors will receive the file of their published article in PDF format. Furthermore, the main author of each article will receive 15 offprints if he is a member of SEHCYT.

Reviews of books sent to *Llull* should deal with works published in the current year or the one immediately before. Publication of popular science will be limited to really exceptional cases.

In book reviews, the authors will strive to offer a brief and clear synthesis of their contents as well as, obviously, any criticism or considerations the author of the review may deem appropriate, especially for science historians and academics of that particular field.

Reviews must be written in no more than 1,500 words. Descriptive information on the book should appear in the heading of the review following this order: title (uppercase); author; author of the foreword, if any; collection and number, if any; editor; place of publication; number of pages; ISBN, and price.

Reviews may be sent to the review coordinator or to the editor of the Journal. In all cases, the reviews shall be submitted for appraisal to the review coordinator for the area covered, who shall decide whether it is accepted or not. The Editorial Board shall decide on the publication of any review that does not fall within the area of responsibility of any particular coordinator.
